We wanted to let you know that we cannot discuss the new DEER on today's conference call. We'd like our discussion today to focus on the custom measure workpaper process.

In addition, in discussion with the other IOUs regarding the conference call on Friday March 5, I learned that the workbooks that have been released are based on a revision of the 2008 DEER that has not been published yet. Since the CPUC froze the DEER in its final 2010-12 decision which we then used in our compliance filing, the workbooks need to be revised to be based on the adopted DEER (not the new version). Is that your understanding as well?

Thanks for continuing to work with us toward the March 31 deadline. It will be good to get everything locked down by this deadline so that we can fully move forward in implementing our portfolios and measuring our progress.

Hope you get a chance to read this before our meeting; please drop me a line letting me know so we're not confused by the time the conference call starts.
