Good morning Steve,

As a follow up to my voice to you Friday afternoon, attached is a file that is currently under review. It contains all actual meter deployments by month and by meter reading office. This was the most accurate way to get you actual information on the past deployments. the sites generally start with a few meters per month as pre-deployment activities and you can identify when the mass deployment began by the jump in the installed numbers.

Combined with what Karen provided you earlier for the future plans, this should provide you with the information you are looking for. We are currently reviewing this data pull and will provide it through a formal DR response. Meanwhile, if you let me know the format you would like the data, we can work on that as well prior to submitting the supplemental response.
