QUESTION 4

Exhibit PG&E-7, Chapter 7, page 7-26, and Table 7-3 provides the A&G expenses for the Environmental Program. Please provide the 2009 recorded A&G expenses for MWC AB (Support) and MWC IE (Environmental Remediation, Non-HSM Recovery).

ANSWER 4

PG&E objects to this data request to the extent it asks for 2009 actual data while PG&E's 2011 GRC request is based on 2008 actual data. Notwithstanding the foregoing and without waiving PG&E's right to object to the admissibility of such data, PG&E responds as follows:

The 2009 recorded and forecast A&G expenses for MWC AB and MWC IE are summarized in the table below.

As described in Exhibit (PG&E-7), Chapter 7, pages 7-11 through 7-16, MWC IE A&G expenses reflect the increased labor, contract, legal support, and miscellaneous costs necessary to accelerate remediation of PG&E's historic contamination sites. Recorded costs were slightly higher than forecast because additional labor was required to manage new environmental remediation projects.

MWC AB A&G expenses are described on pages 7-8 through 7-15. Recorded costs during 2009 were \$1.1 million less than forecast because expenditures supporting habitat and species protection were planned in MWC AB but charges were actually incurred against MWC AY (see response to Question 5 for additional discussion).
