

All,

I believe that Energy Division and our DEER Team consultant Marlin Addison now have all of the input and additional files needed to fully review the PWRHP work papers. Thank you for your timely response to our request for additional information.

ED would like to propose the following schedule to complete the PWHRP workpaper review:

Proposed Schedule for Completion of Energy Division Review of PWHRP work papers:

- 1) Utilities provide Energy Division with the requested additional modeling files (March 9-DONE)
- 2) Energy Division/DEER team fully reviews the models once provided by the IOUs
- 3) ED/DEER team provides the models back to the IOUs with any changes as needed (time estimate: one week, i.e. March 16-17)
- 4) IOUs provide any written comments back to ED/DEER team by COB Tuesday March 23rd (Note: DEER team consultant is available for consultation during this period except for during March 17-19)
- 5) March 24 (morning) hold ED/DEER team-IOU engineering staff conference call to discuss issues raised, determine if follow up work papers and/or model inputs are likely to get to a 20% threshold or not.

If it is agreed that the 20% average savings threshold is not met: 6) IOUs have some time period to continue review (one week?) and provide feedback and proposed revisions to the measures and/or savings estimates sufficient to bring average savings to 20% level (ie, approx time frame: March 30). If you have any feedback on this proposed process, please let me know. On Thursday

(tomorrow), I will move ahead with arranging the proposed conference call for March 24th morning. I believe that this can be an all-IOU call.
