Decision 07-09-043 requires the Energy Division to issue a final report on the 2006-2008 energy efficiency programs managed by PG&E, SCE, SDG&E and SoCalGas. The draft version of this report is due April 15, 2008. The report has been posted along with the technical appendices and tools (ERT) to support the values in the report. The document and appendices A-J are provided at the energy data website for public comment, which are due May 17th. A workshop will be held on April 23 to explain the evaluation reporting tools used to develop the report, and a workshop on the report results will be held on April 30, to answer questions regarding the report. These workshops will be noticed separately to the appropriate service lists.
