Based on discussions with all the IOUs when we met on this a few months ago, I think the immediate reporting will have to act an interim fix before the next CE tool is ready. So if we want to get something up and running now, I say let's operate under the assumption that we'll be using the E3 calcs at least for 2010.

The web portal is interesting because I'm hearing more about it from Redacted and I don't see a whole lot of work needed on the reporting side of things. Meaning, whatever we (CPUC, IOUs) come up with will just link to the web portal, but we're still going to have an EEGA web based system for 2010-2012 that is fully accessible to the public. But with the web portal, maybe more in the energy community will be aware of it.

The issue that I have trouble visualizing is the new requirements from the decision (or any recent decisions) and PPMs (performance metrics).
