Hello,

thanks. I have three questions

1. Is the eligibility for TANF the same as CARE or different?

The income eligibility is the same as CARE (200% of federal poverty). The remaining

guidelines are outlined below.

2. How can a customer get TANF?

In order to be eligible for REACH and TANF assistance, each applicant must:

- Have a Residential Account with PG&E in the name of applicant
 - Demonstrate an uncontrollable or unplanned change in the ability to pay PG&E bills
 - Currently receive TANF assistance or be an adult with children under 18 in the family, or a non-custodial parent with children under 18 in the family
 - Have a 15-day or 48-hour notice of pending shut-off (*Documentation Required*)
 - Meet income requirements which are currently at or below 200% of the federal poverty guidelines (*Documentation Required*)
- *Maximum REACH pledge is \$1,500 (\$300 REACH and \$1,200 ECF)*
