

### **CPUC To Hold Voting Meeting In L.A. On April 22nd**

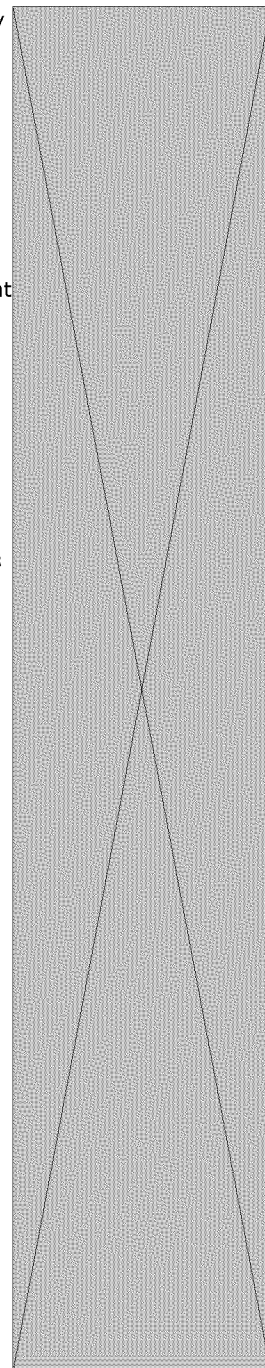
The CPUC's April 22, 2010, voting meeting will be held in Los Angeles at 10 a.m. at the Reagan Building at 300 South Spring Street.

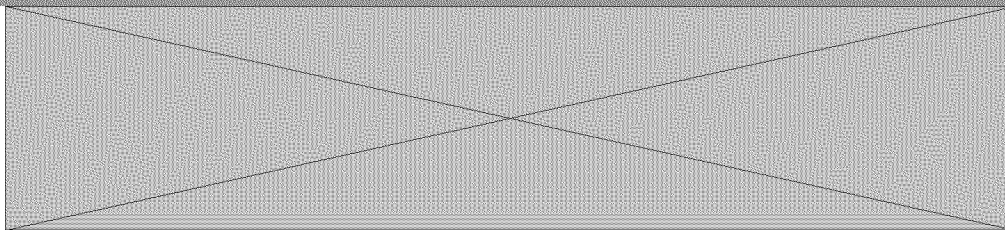
