**NOTICE OF *EX PARTE* COMMUNICATION**

Pursuant to Rule 8.3(a) of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) hereby gives notice of the following *ex parte* communication. Two separate communications occurred on Friday, April 2, 2010, at approximately 10:30 a.m. and 11:00 a.m. at the offices of the California Public Utilities Commission in San Francisco. The communications were oral and included handouts, which are attached to this notice. [Rule 8.3(a)(c)]

John Hughes, Director- Regulatory Relations, PG&E, initiated the communication with Andrew Campbell (Advisor to Commissioner Nancy Ryan), and Karl Meeusen (Advisor to Commission President Michael Peevey), respectively. Frances Yee, Project Manager-PG&E, and Jennifer Post, Attorney-PG&E, were also in attendance. [Rule 8.3(b)]

The PG&E representatives discussed the attached handouts that outline the main subjects of both Applications: 10-01-014 and 10-01-022, PG&E's request to recover costs associated with the Diablo Canyon Power Plant operating licenses. Mr. Hughes stated that the purpose of the meeting was to clarify any misconceptions that may exist regarding PG&E's knowledge of possible issues. Ms. Post referred to letters that had been sent to the Commission that indicated

that PG&E had insufficient knowledge of the newly-identified Shoreline fault. Mr. Post pointed out that these statements were wrong.

Ms. Yee and Ms. Post also addressed the timing of the license renewal application. They stated that the Commission does not need to delay the consideration of Application 10-01-022 pending the results of the 3-D seismic studies. [Rule 8.3(c)]
