<u>Columns B and C</u> show the Cost Center and Cost Center Description.

<u>Columns D through G</u> represents the sum of orders charged to the cost center in each year totaled by cost category (Capital, Expense, Non Expense Earnings, and Other).

Columns H through J are calculated as explained below.

<u>Column H</u>, Total, calculated in the spreadsheet, is the sum of columns D through G.
