MOTION TO DISMISS DEFENDANTS

Gill Ranch Storage, LLC ("GRS") and Pacific Gas and Electric Company ("PG&E") hereby file this Motion to Dismiss Defendants Joseph Curtis Edmondson ("Edmondson"); Jimmy L. Graham, Trustee of the Jim Graham Trust dated October 30, 1984 ("Jimmy L. Graham"); and Vern Jones Oil & Gas Corporation ("Vern Jones") from the Complaint for Authorization to Condemn Property in the Public Interest Pursuant to Public Utilities Code section 625, Case 10-02-001 ("Complaint").

1. Introduction.

On February 2, 2010, GRS and PG&E filed the Complaint for authorization to condemn certain pipeline easements and mineral interests necessary to carry out the Gill Ranch Gas Storage Project ("Project") and protect its safety and usefulness. As stated in the Complaint, GRS' and PG&E's strong preference is to obtain property rights for the Project through mutual agreement. GRS and PG&E also stated their intent to remove parties from the Complaint, to the extent GRS and PG&E are able to reach agreement

with any of the Defendant property owners named in the Complaint, or otherwise resolve property rights issues, while the Complaint is pending before the Commission.² Through this Motion to Dismiss Defendants, GRS and PG&E seek to dismiss three Defendants from the Complaint, as described below.

2. Dismissal of Mineral Interests Defendants.

Since filing the Complaint, GRS and PG&E have reached agreement with Defendants Edmondson, Jimmy L. Graham, and Vern Jones regarding mineral rights owned or leased by each within the Storage Field Boundary for the Gill Ranch Gas Storage Project (both as defined in the Complaint), as particularly described in the Complaint. Thus, GRS and PG&E request to dismiss Edmondson, Jimmy L. Graham, and Vern Jones from the Complaint as Defendants.

Appropriate revisions to Exhibits D and F, and the service list for this proceeding, have been made to reflect the removal of Edmondson, Jimmy L. Graham, and Vern Jones as Defendants.³ Changes resulting from this Motion to Dismiss Defendants are shown in strikeout in Attachments 1 (Exhibits) and 2 (Service List) hereto. Clean versions of the revised Exhibits and service list are included in Attachments 3 (Exhibits) and 4 (Service List) hereto.
