First, I'd like to take this opportunity to thank each of you for your robust participation in the recent CPUC Policy and Planning hosted-ACWA Energy Committee meeting. I believe the ACWA members, as well as the participating Investor Owned Water Utilities, found it to be extremely useful as did Commission staff. May this be the beginning of several rich exchanges regarding the water and energy nexus bringing the water and energy utilities together at the Commission! I know it takes time and effort to put presentations together, to take time out to travel, etc., and I am very grateful for the time and energy!

Second, I am doing a recap of the Joint Utilities meeting on a panel at the Spring ACWA meeting May 4-7, and I'd particularly like to give the ACWA members a clear idea of the opportunity which exists for them to participate in your EE and Renewables programs. I think one way to do this is to discuss the amount of energy (both absolute magnitude and percentage of total commercial industrial sector energy) for each energy IOU which is used by the water and wastewater sector. Would you be so kind as to provide me with estimates of the magnitude and percentage of your total commercial/industrial energy used by the water and wastewater sector customers? If you have any other data i.e. potential for EE and or renewables in your water sector customers, etc., which you would suggest using to inform ACWA members, I'd be grateful for that as well. Some of you included this in your presentations and others did not so I want to make sure I have data for all of you.

Thanks so very much! The Spring ACWA meeting is May 4-7 so I would love to have this data ASAP so I can finish my presentation. I will be distilling quite a bit

of information from your fine presentation at the Joint Meeting and thanks again for doing such a fine job!
