Dear Judge Darling:

On Friday at 5:40 p.m. PG&E served a motion to file under seal its confidential version of its joint petition to modify the decision 09-904-010, which is also subject to Group Petitioners' still pending petition to modify filed in June 2009.

As I mentioned to the attorneys for PG&E by both voicemail and email yesterday, the moving party to file under seal, to date I still have not received a confidential version of the joint petition. (The hard copy on the motion I received was postmarked April 19, 2010.) Presently under Rule 11.4, any response would be due on Monday, April 26, 2010.

Pursuant to Rule 11.6, I contacted the attorneys for PG&E copying their secretary Sharon Mortz who served the motion below. Although I received an automatic reply from Alice Reid that she is out of the office until Monday, April 26, so far I have not received a response from PG&E to my request for an extension made to both Ms. Reid and Charles Middlekauff.

Therefore, pursuant to rule 11.6, this is to request that you extend the time for the parties to respond by at least 10 days up to and including May 6, 2010.

Please let me know whether there is anything further you require concerning this request.
