Dear Judge Darling:

According to the docket entries for this action, the joint petitioners California Unions for Reliable Energy, Division of Ratepayer Advocates,

Pacific Gas and Electric Company, Russell City Energy

Company LLC and The Utility Reform Network filed their petition on April 15, although service was not effected as to Group Petitioners until April 20, 2010. Presently under Rule 16.4, "[r]esponses to petitions for modification must be filed within 30 days of the date that the petition was filed," which here would fall on Saturday, May 15, 2010, or applying Rule 1.15, would fall on Monday, May 17, 2010. Presently also scheduled on May 17, 2010, is the pre-hearing conference.

Later that same week I have to be in Los Angeles for other business and on May 20, 2010, I have a hearing in another action in the North Counties. In response to my request to extend the due date to and including to Monday, May 24, 2010, due to my being out of town and the scheduling of the prehearing conference, the attorneys for PG&E (informing me verbally they had no objection) inquired into whether the other joint petitioners would have any objections to extending the time for Group Petitioners to respond to the Joint Petition given I will be out of town for most of that week. Although all joint petitioners, except for RCEC or Calpine, apparently do not object to such an extension to and including to May 24, 2010, for some unstated reason Calpine does object to that extension, although agreeing to an extension until May 20, 2010, when counsel for the joint petitioners know I will be out of town.

Therefore, pursuant to rule 11.6, this is to request that you extend the time for Group Petitioners to respond to the Joint Petition for Modification which was effectively filed on April 15 but not served until April 20, 2010, from May 17, 2010 to and including May 24, 2010.
