- The contract listed on row 236, a wind facility named Arlington Valley (LS Power), appears to actually be PG0928 Arlington Valley Solar Energy I, a solar facility. Please verify the technology and whether it is a bundled a or unbundled transaction.
- Are negotiations terminated with Quay Valley Solar? If not, Quay Valley Solar/Dalu (PG0955 in the PDSR, in Kings County, CA), is identified as an unbundled REC contract. This looks like a bundled in-state contract, at least as of the February 12 2010 PRG.
- Naturener: the REC filing lists a large amount of RECs from a Naturener deal. Is this PG0947 WIldrose? If so, the PDSR doesn't include generation amount so please confirm the amount provided in the REC filing, confirm project location and provide an update on the negotiations since this is a significant amount of generation.
