Description of Work To Be Performed:

Contractor shall perform the following Scope of Work in accordance with the Contract identified by the above PG&E Contract Number. Payment will be made under the terms of Paragraph 6.1.3 of the General Conditions.

Scope of Work: Retrieve new ROil faxes daily off dedicated fax line located in Room 2316. Email/scan faxed printouts to a SH&C Representative using the HP color LaserJet 4730mfp machine in Room 2324. The scanned faxed forms will be placed into a PG&E interoffice envelope and routed to the Safety Manager's assigned point of contact located on the 28th floor of this building. The estimated quantity of incoming ROil faxes to be processed is 50 weekly. The timetable for this additional work project will commence on November 5, 2007 through June 30, 2008. This special work project will be performed during our regular business hours and incorporated into our existing, daily facsimile delivery schedules. PG&E, SH&C will furnish all equipment associated with this special work project.

Estimate of Cost: Estimated at no more than 120 labor hours will be required to complete the assignment between November 2007 and June 30, 2008. Billing will be at an hourly rate of \$25.00 per hour. These additional work project hours will be billed on a month-to-month basis until this project is completed on or prior to June 30, 2008.

Rationale: Assist PG&E in their process improvements initiatives to the SH&C Department's new ROil Incident Reporting System processing with rapid turnaround distribution of e-mailing & scanning new ROil faxes to the SH&C clerical.
