Marzia - I just wanted to confirm with you that PG&E will be holding an informational open house to answer SmartMeter questions from our Sonoma County customers on Wed, 4/28 from 5:00 p.m. to 10:00 p.m. at the Veteran's Memorial Hall at 282 South High Street. Much like our Answer Centers, PG&E will have representatives on hand to talk about the SmartMeter program, answer customer billing questions, talk about other programs and services PG&E offers, etc., and we will have experts on hand to specifically address radio frequency concerns.

Honorable Elected:

As you are aware, PG&E decided not to participate in the recent county-wide SmartMeter™ forum due to several significant format changes that caused the company and our experts to feel we could not have a meaningful dialogue with our customers.

However, we understand there are customers who would like more information about the PG&E SmartMeter™ system and program, and who have questions they want answered. Therefore, we will hold a SmartMeter™ Open House on Wednesday, April -28th at the Sebastopol Veterans Hall from 5PM to 10PM to give our customers an opportunity to have their questions answered.

We will have a variety of in-house experts and at least one outside expert on-hand to answer customer questions related to the SmartMeter™, radio-frequencies, energy efficiency, billing, and payment assistance options such as the CARE program. We encourage residents to visit us anytime between 5PM and 10PM to learn more.
