Hi Julie and Frank, following up on our conversation last week about the possible QF Summit arbitration process, did either of you have a chance to check in with Paul about his travel schedule/availability to participate as a possible 3rd arbitrator? I believe the schedule we've been working with the parties provides for significant arbitrator involvement the first couple of weeks of August, with presentation of final packages to arbitrators on July 30 and then a couple of weeks for you to evaluate and make a call. So that would be when you and Paul would need to be available. I realize we discussed other considerations about Paul's involvement and it is still a topic of discussion among the parties, but as a threshold matter we wanted to know if he is even going to be around during that time, and when we met you had offered to check his calendar. If you could let us know if he'll be around then, that would be great. Thank you!
