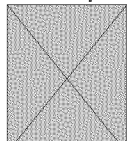

Frances Spivy-Weber, Vice Chair of California's State Water Resources Board, will discuss the Board's newly released policy on the use of coastal and estuarine waters for power plant cooling.

Fran was re-appointed as the Public Member of the State Water Resources Control Board on March 1, 2009. She serves as Vice Chair of the Board and is the liaison to the Los Angeles, San Diego, Central Coast, and Lahontan Regional Boards and the Ocean Protection Council Steering Committee. Fran has served on numerous state and regional water advisory groups and task forces, including the Bay-Delta Public Advisory committee, co-chairing its Water Use Efficiency Subcommittee; State Water Plan 2005 Advisory Committee; California Landscape Task Force 2005; State Water Recycling Task Force 2003; Governor's Advisory Drought Planning Panel 2000.

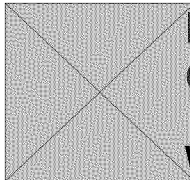

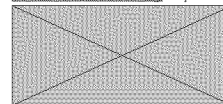
