Pursuant to Paragraph Two of the December 21, 2009 Ruling of the Assigned Commissioner and Administrative Law Judge (ALJ) Directing Applicants to Amend Application and All Parties to Meet and Confer and the May 4, 2010 procedural e-mail from ALJ Maribeth Bushey, Southern California Edison (SCE), San Diego Gas & Electric Company (SDG&E), Southern California Gas Company (SoCal Gas), Pacific Gas and Electric Company (PG&E), Division of Ratepayer Advocates (DRA), Disability Rights Advocates (DiRA), Consumer Protection and Safety Division (CPSD), Mussey Grade Road Alliance (the Alliance), The Utility Reform Network (TURN) and Ruth Hendricks submit the following joint status report.

Representatives of SCE, SDG&E, SoCal Gas, PG&E, DRA, DiRA, CPSD, the Alliance and TURN met and conferred, in person, on May 13, 2010.<sup>1</sup> On May 24, 2010 representatives of SCE, SDG&E, SoCal Gas, PG&E, DRA, DiRA, CPSD, the Alliance, TURN and Ruth Hendricks met and conferred, in person.<sup>2</sup> Administrative Law Judge Janet Econome facilitated the meet and confer process as an Alternative Dispute Resolution Neutral.

The parties are currently considering next steps. The parties propose to file recommendations for procedural next steps on or before June 14, 2010.
