Shilpa,

I just want to clarify that PG&E should already have all of the underlying data for the 2008 Itron EE Potential Study, which was done under contract to PG&E and included delivery of the ASSET model and input and output data sets. It is with respect to the subsequent work for the CPUC Goals Study that we would need clarification on delivery of electronic data, though there is no additional cost data that was developed for the Goals study.

I don't recall whether electronic data from the goals study was provided to the utilities or just the detailed PDF appendices but I think electronic data was provided. I think Michael Wheeler and Mike Ting (Itron) can refresh our memory on that one.

Jean Shelton (Itron) and [Redacted] were the PMs on the IOU potential study and I think can confirm the electronic data PG&E should have currently from that effort.

Jeanne, Simon, Michael,

We understand from Itron that the underlying data to the 2008 potential study cannot be released without your permission.

As background, we're trying to use the data to inform our AB 32 analysis

about the potential in EE and the associated costs by the source technology and by year through 2020.

The results at a higher level are available in the report itself, but we'd like to see the underlying data (assumed TRC, IMC, utility cost, EUL, EUS, etc). Can you please provide your consent so that Itron can release the data?

My understanding is that the data is not necessarily confidential, but Itron needs your approval before release.
