Steve - thanks for your note. Unfortunately, we won't be able to comply within the time period you have requested. I believe PG&Es accounting books close for a specific month in the second week of the following month - so April data won't even close internally until the second week of May. In addition, data is often not available for aggregation until about the third week of the month when all the reconciliation becomes available in SAP. I will ask Daren to check with Accounting and Finance about the specific times for closing and reconciliation. I also ask that Daren get you a date by which we can comply with your request as expeditiously as possible (soon after the accounting information is available). I have cc'd Jane Yura, our VP of Regulation and Rates, to make sure that she has a case manager in her organization who will compile the data for transfer to you.

I would request that you not release any BTL information to external parties until I receive clarification from internal parties that this is proper. Given the late hour on Friday, I can't get that authority today. My general feeling is that it would be inappropriate to share BTL information with external parties. One could argue that BTL information is proprietary to PG&E and is being provided to the Commission to aid them in their efforts to ensure customer funds are not used in activities for which they are prohibited. However, that doesn't mean they would not remain protected under S583. Keep in mind that I'm not a lawyer - just a layman - and I will get a more complete answer Monday.
