Dear Zeny and Tim,

Attached is a summary of each IOUs' estimate of unspent EM&V funds as of September 30, 2009. This information is provided in compliance with Decision 10-04-029 that directed the IOUs to submit a report to Energy Division within 15 days of the effective date of the decision documenting the EM&V amount unspent as of the effective date of D.09-09-047. (at p 11) As Tim clarified, this report only includes the IOUs' portion of EM&V.

Please note that this report represent the authorized EM&V for PY 2006-2008 and PY 2009, expenditures through September 30, 2009, and forecasts commitments as of that time period. The estimated carryover does not reflect the amount currently available to reduce customer rates, as it does not include the Energy Division's portion of expenditures and commitments or any carryover amount that the IOUs have incorporated into customer rates subsequent to and in compliance with D. 09-09-047. By mid-2010, prior to the IOUs' preparing their annual advice letters to establish 2011 customer rates, it will be important to update this report with more current information, including both the IOUs' and Energy Division's portion of unspent EM&V.
