Attached with the letter are 38 pages of a "petition to stop the  
wholesale destruction of 140 trees in TJ Martin and Jeffrey Fontana  
Parks". Only two pages of the 38 signed petition pages, are attached to  
this e-mail. Please let me know if you need a full copy.

They are writing to make PG&E aware of an issue the community has been  
working with for three months regarding destroying 140 trees in the  
area. They have been speaking with Don Hall and [Redacted] in the  
PG&E San Jose office.

They believe that PG&E has shifted away from a strategy of pruning to  
one of cutting purely for convenience and monetary savings. They have  
discovered court cases that support their position. They consider  
PG&E's actions unreasonable and unnecessary.

Since they have reached an impasse in discussions with PG&E, they have  
begun discussions with the "No" on Prop 16 Campaign. (FYI: Andrew,
