Dear George/Zeny,

We would like your concurrence that the requirement in Decision 09-09-047 to begin reporting fundshifts in EECA on a quarterly basis beginning July 1, 2010, has been moved out to a later date still to be determined. Decision 09-09-47 Ordering Paragraph 43e states: "In addition to the requirements of OP 46 [sic - should be OP 43b] IOUs are required to inform Energy Division in writing every 90 days beginning July 1, 2010, of any fundshifting away from any budget levels approved in this decision or through the compliance AL required by OP 15. This report shall be posted on EECA website."

Given that Energy Division and IOUs have just begun discussions on the 2010-2012 EECA reporting requirements (with the first meeting held in San Diego June 14 - 15) it is not feasible to begin quarterly EECA reporting by July 1.

Please provide your concurrence or additional guidance on this compliance matter.
