NOTICE OF *EX PARTE* COMMUNICATION

Pursuant to Rule 8.3(a) of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) hereby gives notice of the following *ex parte* communication. The communication occurred on Tuesday, June 15, 2010, from approximately 8:40-9:00 a.m. The communication was verbal and took place at the site of the 2010 Western Conference of Public Service Commissioners at 905 Country Club Road in Ojai, California. No written materials were used. [Rule 8.3(a)]

Trina Horner, Director-Regulatory Relations, PG&E, initiated the communication with Karl Meeusen, Energy Advisor to Commission President Michael Peevey. [Rule 8.3(b)]

Ms. Horner expressed PG&E's strong support for all of the projects selected as part of PG&E's 2008 Long Term Request for Offers (LTRFO), including the Oakley Generating Station which will provide complementary operational benefits to the peaking plants selected in the LTRFO. She also emphasized that PG&E's LTRFO was fair and not "black box" as the proposed decision suggests, noting that the evaluation criteria and process were shared in great detail with PG&E's Procurement Review Group, Energy Division and Independent Evaluator at every step of the evaluation process.
