The communication occurred on Tuesday, June 15, 2010, from 11:00-11:45 a.m. by telephone to the offices of the California Public Utilities Commission. No written materials were used. [Rule 8.3(a)]

Trina Horner, Director-Regulatory Relations, PG&E, initiated the communication with Theresa Cho (Chief of Staff to Commissioner Dian Grueneich), Michael Wheeler (Energy Advisor to Commissioner Dian Grueneich), and Dries Berghman (Intern in Commissioner Grueneich's office). [Rule 8.3(b)]

Ms. Horner summarized the new generation procurement authorization approved for PG&E in the 2004 Long Term Procurement Plan Proceeding (LTPP) and the projects that resulted from PG&E's 2005 Long Term Request for Offers (LTRFO), as well as the new generation procurement authorization approved in D.07-12-052 and the projects that were selected by PG&E in its 2008 LTRFO. Ms. Horner noted that the procurement authorization adopted in D.07-12-052 was expressly designed to result in operationally flexible, dispatchable

new generation. She emphasized that this procurement authorization was developed considering numerous factors, including such factors as the addition of renewable resources and facility retirements, and was not limited to the peak demand forecast or assumptions on exports to Southern California that are relied upon in the Proposed Decision to conclude PG&E's procurement should be limited to the lower end of the range previously approved. Ms. Horner noted PG&E's strong support for all of the projects selected as part of PG&E's 2008 Long Term Request for Offers (LTRFO), including the Oakley Generating Station which will provide complementary operational benefits to the peaking plants selected in the LTRFO.
