Re: Correction of Information to PG&E's March 25, 2010 Ex parte Communication

(PG&E's 2011 GRC Phase 2 Application (A.10-03-014))

During a previous Ex Parte meeting on March 25, 2010 between Dennis Keane, Brian Cherry and John Hughes of PG&E and Andrew Campbell and Sepideh Khosrowjah, Advisors to Commissioner Nancy Ryan, PG&E provided information that PG&E has subsequently learned was incorrect. In comparing PG&E's residential rates to those of SCE and SDG&E, PG&E erroneously represented SDG&E's California Alternate Rates for Energy (CARE) electric rates due to tariff ambiguities. (At the time of the meeting, calculating SDG&E's CARE rates required combining information from three separate tariffs, Schedules DR-LI, EECC, and DWR-BC. Subsequently, SDG&E has updated its tariffs and now shows CARE rates in a single DR-LI tariff page.)

The original and corrected January 1, 2010 SDG&E CARE rates are summarized in the table below:

PG&E is providing you an updated version of the table it shared with the Commissioner advisors on March 25, with the SDG&E rates corrected. We apologize for any inconvenience or misunderstanding this may have caused. Although these corrections show reduced SDG&E rates from what was presented on March 25, PG&E's point remains the same: Even with the introduction of a new CARE Tier 3 rate of \$0.125 per kWh, PG&E's proposed CARE rates in Phase 2 of its GRC will remain below those of SDG&E and SCE.
