
I, Richard A. Peraza, am a citizen of the United States residing in San Bernardino County, California, and am over the age of 18.


I am now, and at all times referred to below, have been employed by the San Diego Gas & Electric Company as Communications Advisor in Los Angeles, California.

TO DECREASE ELECTRIC RATES

On April 30, 2010, San Diego Gas & Electric Company (SDG&E<sup>®</sup>) filed its Expedited Energy Resource Recovery Account (ERRA) Trigger Application (Expedited ERRA Trigger Application) with the California Public Utilities Commission (CPUC) asking for approval to decrease certain rates. The ERRA was established by the CPUC to record the utility's fuel and purchased power revenues against recorded costs, excluding costs and revenues related to the California Department of Water Resources. Assembly Bill (AB) 57 mandated a trigger threshold for the balance in the ERRA of 5% of the electric utility's recorded generation revenues for the prior calendar year. Under the provisions of the trigger mechanism, SDG&E is required to file an expedited application to address the ERRA balance when it reaches an under-collection or over-collection of 4%, and is projected to exceed the 5% trigger.

Specifically, the Expedited ERRA Trigger Application seeks approval to return a \$100 million over-collection in the ERRA under the adopted trigger mechanism, partially offset by a \$26 million under-collection in the Non-Fuel Generation Balancing Account (NGBA), which records the difference between actual non-fuel generation costs, including SONGS and natural gas-fired generation, and recorded commodity revenues. Accordingly, SDG&E is proposing a rate decrease of \$74 million to be amortized over 12 months from September 1, 2010 to August 31, 2011.



### EFFECT ON ELECTRIC RATES AND BILLS

If the CPUC approves SDG&E's request, a typical non-CARE inland climate zone residential customer's summer electric bill using 500 kilowatt-hours of electricity will decrease from \$78.57 per month to \$77.75 per month, or \$0.82. Changes in individual bills will depend on how much energy each customer uses.

### EVIDENTIARY HEARINGS

Evidentiary Hearings (EHs) may be held whereby parties of record will present their testimony and are subject to cross-examination before an Administrative Law Judge (ALJ). These EHs are open to the public, but only those who are parties of record can present evidence or cross-examine witnesses during the evidentiary hearings. After considering all evidence presented during the formal hearing process, the assigned ALJ will issue a proposed decision. The CPUC may approve a rate decrease that differs from that proposed by SDG&E. The actual rates may result in changes greater or less than those described in this notice.
