Shilpa and Simon,

Jordana and I have had a chance to confer on this- we are both at the training and Jordana had the ZNE PIP with her.

The proposed metric relates to the PIP statement of intent under subprogram ZNE Design Integration to "investigate the development of market-based financing mechanisms to create grid neutral development." (p 27)

We can see that a different metric than what we initially proposed may be needed; however, it does not seem like what PG&E proposed goes far enough. The "to who" and "what" will be shared is not clear.

We would therefore propose this:

- 2011- share findings from market-based financing mechanisms investigation at PG&E-led ZNE workshops
- 2012 - by mid-year, submit memo to Energy Division summarizing top three most promising market-based financing mechanisms identified via investigations and, share memo and discuss at OBF and and other PG&E-led ZNE workshops

Simon,

Sorry the timing doesn't look like it is going to work this week. In the future, we should probably just schedule calls right after we receive your comments so we can review and discuss (and cancel if they are not necessary). We'll plan to go ahead and file just so we can stay on track to launch and implement this program.

As I noted in my email yesterday, we're accepting all of Cathy's proposed changes, except for the proposed metrics. We wanted the metrics to tie to our learnings from the OBF program so the timing and language needed to be revised.

Here is the current language:

i. Market Based Financing Mechanisms:

1. Target 2011 - Develop 2-4 preliminary financing mechanisms from the 2010 workshops, and present/gather feedback at the 2011 scheduled workshops.
2. Target 2012 - Revise financing mechanisms and disseminate to leading practitioners and broader stakeholder audiences.

We revised to state:

i. Market Based Financing Mechanisms:

1. Target 2011 - Share findings from investigation at workshops.
2. Target 2012 - Share OBF results and discuss linkages with investigated financing mechanisms at workshops.
