John Hughes, Director- Regulatory Relations, PG&E, initiated the communication with Commissioner Dian Grueneich. Commissioner Grueneich was joined by her staff: Theresa Chow (Chief of Staff), Matthew Tisdale and Michael Wheeler (Advisors). Prior to the meeting, a 3-day Notice of Grant was filed at the request of Commissioner Grueneich's office. The purpose of the meeting was a tour of the Diablo Canyon Power Plant by Commissioner Grueneich and her advisors. The request for the 3-day Notice was made in the event that a discussion took place on PG&E's two pending applications pertaining to DCPP (A.10-01-014 and A.10-01-022).
