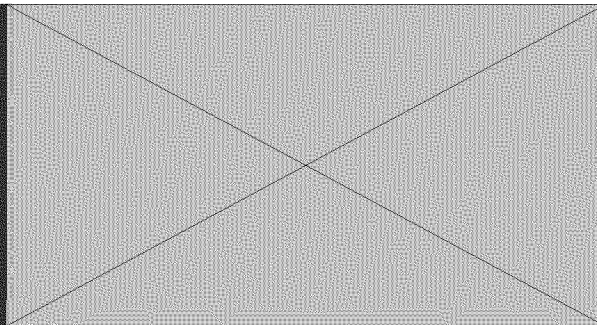

PG&E is installing its wireless so-called "Smart Meters" (replacing our existing electric and gas meters) at every single home, business, school, medical clinic, etc, in the Bay Area & elsewhere. 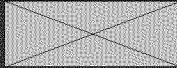
WHEN: Tuesday July 20, 11:30 am to 1:30 pm

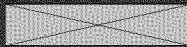
WHAT: Free non-toxic manicure and rally and/ or staff a TTG Table at the event to help educate attendees.

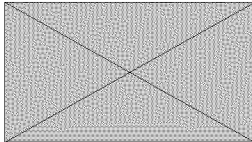
