Steve -- Thank you for preparing an Agenda for the Workshop on DA issues set for next week. I will be out of town and unable to attend but Dr. Barkovich will participate for CLECA. In discussing the Agenda and its list of issues with Dr. Barkovich, a couple of questions/concerns came to mind and I would like to raise them with you and the other parties in advance of the workshop. First, it seems as though you have conflated the issues surrounding the Switching Rules with the general question of the proper level of exit fees. I'm thinking specifically of the several questions under your No. 1 under the Switching Rules heading. I'm having trouble with the concept that "current switching rules adequately account for all costs determined to be non-bypassable". While the switching rules are designed to avoid costs they would appear to have little to do with the CTC or the bond fees for example. While these sets of issues, switching rules and exit fees, can impact one another, they are not the same and I wonder if it would make more sense to keep them separate, at least for starters. Second, the Agenda allows only 90 minutes for the discussion of the Switching Rules/Exit Fee topics. That would not appear to be sufficient time to cover this important set of issues. Third, I note that the second topic is ESP Financial Security Reqs and the third is TBS Rates Updates. Would it make more sense to

switch these two topics, thereby giving the parties a continuous 3 hours to cover Switching Rules, exit fees and TBS issues? I hope you don't find these questions/suggestions offensive. There are a lot of important issues to cover and not a lot of time in which to do so. Bill
