Once again IOU's need ED's estimate of unspent/uncommitted EM&V funds for prior program cycles (06-08 and 2009) in order to determine the amount of EM&V carryover that can be used to reduce 2011 rates, per D.09-0-047. I would appreciate your **response by July 28, 2010**, so that the information can be incorporated into the electric rates PG&E will file in its 2011 Annual Electric True-up advice letter due by September 1. The information will also be incorporated into 2011 Gas PPP Surcharge rates to be filed by October 31.

I have attached the spreadsheet you provided last year for reference. Also attached for reference is a summary of EM&V expenditures for PG&E, including ED's portion, recorded through June 2010.
