Dave, Deana, Wendy, Mike, Noel and Dave:

This afternoon Deana Ng and I talked with ALJ Kolakowski and walked through with her our proposed schedule for convergence bidding. She was very open and receptive to our proposal, with a few additions. I have added in to the schedule supplemental comments on the 20 questions after the workshop, but before the utility proposals are due, and a date to request evidentiary hearings, as well as a hearing regarding evidentiary hearings if necessary (these two items were included in ALJ Kolakowski's original schedule). She understood that we were all pressed for time and seemed very open to a later filing of proposals so that parties have a chance to really prepare and refine their proposals. She also indicated that she did not believe that our schedule would impact the October 2010 date for the issuance of a proposed decision, which is included in her original schedule.

She asked that we file a written request. Attached is a revised version of what I sent out this morning, with the additional items, and some clearer language regarding no changes in the date for a proposed decision. I plan to file this by tomorrow morning no later than 9:00 a.m. Please let me know by COB today (or the latest 8:00 a.m. tomorrow) if: (1) you are signing on as a joint party; and (2) any edits. If you have edits, please copy the whole group so that everyone can see and sign off.

Thanks for the quick turnaround on this.
