SAN DIEGO GAS & ELECTRIC COMPANY NOTICE OF PROPOSED INCREASE IN ELECTRIC RATES APPLICATION NO. A.10-07-009

On July 6, 2010, San Diego Gas & Electric Company (SDG&E[®]) filed an application with the California Public Utilities Commission (CPUC) requesting authority to increase its base rates, effective 3rd Quarter 2011. SDG&E's application includes a detailed forecast of the incremental cost being requested and a description of why this increase is necessary and reasonable.

SDG&E's request extends rate options to the Small Nonresidential and Residential customer classes, in accordance with the Commission's policy to make dynamic pricing available for all customers. SDG&E's proposed rates presented in its application constitute "dynamic" or "time-differentialed" pricing rates in that they are priced based on electric usage according to the time-of-day and the demand response of electric customers. In addition, SDG&E will be day and the demand response of electric customers. In addition, SDG&E will be able to activate a ReduceYourUse Day when it determines there is a genuine need to call on customers for temporary reductions in electricity demand. The intent of dynamic rates is to encourage customers to reduce or curtail usage when a ReduceYourUse Day is triggered. Because the application requests the adoption of rate designs that are substantially different from, and more complex than, the flat rate structure customers are under today, implementation of the requested rates will require significant customer support and education to ensure that customers have the opportunity to be adequately informed of their new tariff options. Accordingly, SDG&E's application includes corresponding incremental costs reflective of the extensive and necessary undertaking to reach and educate our customers, and to develop the customer tools necessary to and educate our customers, and to develop the customer tools necessary to implement and sustain the proposed dynamic rate options.

EFFECT ON ELECTRIC RATES AND BILLS If the CPUC approves SDG&E's request, a typical non-CARE Inland residential customer's summer electric bill using 500 kilowatt-hours of electricity will decrease from \$78.07 per month to \$77.97 per month in 2011. The impact on each customer and customer class could vary depending on the CPUC's final decision. SDG&E estimates that the requested increase in electric revenues associated with the application during 2011, 2012 and 2013 would be allocated in a manner shown in the table below.

CPUC PROCESS

CPUC PROCESS The CPUC may hold Evidentiary Hearings (EHs) whereby parties of record provide testimony and are subject to cross-examination before a CPUC Administrative Law Judge (ALJ). These hearings are open to the public, but only those who are formal parties of record can participate. The CPUC has its own court reporters who will record the comments of those formal parties of record participating in the EHs. The Division of Ratepayer Advocates (DRA) is an independent arm of the CPUC, created by the Legislature to represent the interests of all utility customers throughout the state to obtain the lowest possible rates for service consistent with reliable and safe service levels. DRA has a multil-disciplinary staff with expertise in economics, finance, accounting and engineering. After considering all proposals and evidence presented during the formal hearing process, the assigned ALJ will issue a proposed draft decision. When the CPUC issues a final decision on the application, it may adopt, amend or modify all or part of the ALJ's proposed decision as written. The CPUC's decision may be different than SDG&E's formal request.
