I wanted to also point out that the CSI RD&D meeting yesterday was very interesting. There is definitely CSI RD&D money being used for PV estimation tools and EE with PV estimation tools that should be leveraged when developing the PEAT tool. Genrick attended in person and I was on the phone. Genrick could give a better summary of his impressions since he was there in person and attended the whole meeting. I would like to have an adhoc call on this so we can all hear Genrick's impressions. Please let me know your availability Weds - Fri next week. I will also invite the other IDSM IOU Reps.

Also, apparently PG&E is entering into a partnership with NREL, E3, and others to develop the next iteration of the BEopt tool (see attached). Is anyone on the IDSM taskforce aware of this effort? How will this sync up or be leveraged with the O-Power effort?

In order to get a better understanding of how PG&E believes O-Power can satisfy the directives of the audit tool development, please forward any documentation you have to give us a better perspective and context on this. Hopefully you have something already handy that won't require additional work. If not, a short one page bulleted list would suffice. We can discuss this at the adhoc audit update call.

Good Morning-

I wanted to follow up with all of you to let you know that I met with management after the audit tool update on Friday. Management was a bit concerned that there appeared to be a misunderstanding that the interim

audit tool (as described in D.09-09-047) was no longer needed. I want to clarify that ED is not under this same understanding and I hope to work with you all to ensure that Tier 2 of the current tool development effort will satisfy the interim audit tool development requirement described in the decision. Without this interim effort, the time line is too long for development of a usable tool.

Since there was no opportunity for ED (as a member of the IDSM task force) to provide feedback toward the vendor selection for this task I am concerned that the current vendor may not have the skill set necessary to address the interim or the final tool development (ex: GPS capability to incorporate anticipated solar generation at customer sites).

I believe you all were going to meet with the vendor to t-up the inclusion of an interim solution. I would like to participate in this discussion. Please let me know when this will take place.
