In any event, at the 2pm meeting, our main interest is to talk to you about the LTPP schedule and how the renewable integration issue impacts that schedule. We do not plan to discuss the RIM itself in any detail (unless you have questions about it). The PG&E team for the 2pm meeting is different than the CAISO conference call --- so just extending that conference call won't work for us from a scheduling standpoint ---- unless I'm missing something and there is a different meeting I'm not aware of. I'll ask around here to see what I can find out about the other meeting. EJ
