Paul and Frank:

Also, to update you on discussions with TURN and DRA since our call. Trina and I sent an e-mail to Joe Como and David Ashuckian at DRA. David is out this week, but did e-mail back telling us to call Cynthia Walker. I am going to try to do that later this afternoon.

Trina and I had a long discussion with Mike Florio about the PTM. First, we apologized if there was miscommunication about the discussions related to the Oakley PSA Amendment and if he felt caught off guard by the filing. I think we resolved any concerns.

Second, we discussed the GWF-Los Esteros advice letter and Commission Novation decision. TURN does not intend to protest the advice letter nor is it going to file an Application for Rehearing of the Novation decision.

Finally, we discussed the Oakley PTM. Mike asked if the Oakley developers could deliver the project earlier than the guaranteed commercial availability date. We explained that this aspect of the PSA had not been amended and thus, although the guaranteed commercial availability date changed from June 2014 to June 2016, the project could be delivered earlier, as was the case under the original PPA. We asked Mike if TURN would support the PTM (or at least not oppose it) if the PSA were further amended to include a "no earlier than" clause for delivery of the project. He said he would need to think about it more and, if TURN could agree to the concept, what the date would be. The ball is in Mike's court to get back to us. Responses to the PTM are due in 30 days, so we have some time for discussion.

Just wanted to give you an update. We will let you know if there are further developments.
