Below is the explanation.

Wet cooled and dry cooled facilities have different generation profiles and therefore, have different average TOD factors. If you compare the same sized wet and dry cooled plants, the dry cooled plant will have a lower average TOD factor. Dry cooling is least efficient in the hottest months during the hottest time of the day. This leads to reduced generation during the highest compensated TOD periods (summer super-peak). Therefore, the dry cooled plant has less generation in the higher multiplier periods which is reflected with a lower overall average TOD number.

The average TOD multipliers were calculated as follows:

wet cooling - \$199.50(post-TOD wet cooled price)/\$162.50(pre-TOD wet cooled price) = 1.228

dry cooling - \$217.83(post-TOD dry cooled price)/\$182.50(pre-TOD dry cooled price) = 1.194

This pricing information is consistent with the advice filing.

Attached is the revised "Response to CUE Final" from NextEra. It clarifies that each tab of the spreadsheet is corrected to include TOD multipliers. Each tab is therefore referred to as Corrected Tab 1, Corrected Tab 2 or Corrected Tab 3. It was confusing having references to both tabs and corrected tabs in the write up when it only should have been corrected tabs. Sorry about that.

On the spreadsheet, the yellow was included in the original that we received from CUE. Kerry don't know what the blue cells referred to. I think the coloring should be ignored.

The key change is the addition of TOD multipliers in cells D34 and D35, which leads to the pricing in E34 and E35. This new pricing then changes the values in the cells throughout the spreadsheet. The addition of the TOD multipliers is included in each tab. If the TOD multipliers are set to 1 than all the numbers revert back to the values in the original CUE spreadsheet.
