Meredith Allen, Director, Regulatory Relations, PG&E, initiated the communication with Andrew Schwartz, Advisor to Commission President Michael R. Peevey. Carol Brown (Chief of Staff to Commission President Michael Peevey), and Nicolas Sher (Legal Division-PUC) joined in the meeting with Mr. Schwartz. Also in attendance from PG&E: Steve Malnight, Vice President-Renewable Energy; David Kraska, Director and Counsel- Environmental and Generation; Wendy Pulling, Director -Environmental Policy; and Diane Ross-Leech, Director-Environmental Stewardship. Mr. Malnight stated that environmental considerations were taken into account in determining whether to move forward with the project. Ms. Pulling stated that based on site characteristics, the risk to condors is remote. Ms. Ross-Leech stated that the site lacks suitable nesting, roosting and foraging habitat. [Rule 8.3(c)]
