Subject: 10-02-005 Update on Settlement Proposals of PG&E and SCE

Disconnection OIR Proceeding 10-02-005

All,

This letter is written on behalf of Pacific Gas & Electric Company (PG&E) and Southern California Edison Company (SCE) as a follow up to the Settlement Conference held among the parties on Thursday, August 5, 2010.

In the discussions, which occurred during the Settlement Conference, the Division of Ratepayer Advocates, the Utility Reform Network, the Disability Rights Advocates, the Greenlining Institute, the National Consumer Law Center, the City and County of San Francisco and the Sempra Utilities (together, the Settling Parties) set forth and discussed the terms of a proposed settlement. During that meeting, the Settling Parties invited PG&E and SCE to prepare a settlement proposal which reflected parallel provisions to those contained in the proposed settlement.

PG&E and SCE intended to provide a settlement proposal by today, Wednesday, August 18, 2010. However, due to the many intricate calculations involved in finalizing such a proposal, we were not able to do so in the time provided. PG&E and SCE anticipate it will take an additional three to four weeks to prepare such a proposal. We regret the delay, but feel that it is necessary to adequately evaluate the significant cost and operational implications of the many provisions contained in the proposed settlement. We hope the Settling Parties understand this given that PG&E and SCE became aware of the pending settlement discussions between the Settling Parties only recently and received the proposed terms of the settlement only two weeks ago.

We are committed to continuing to working with the Settling Parties to see if a settlement can ultimately be reached in this proceeding. Please understand that because of the variations in the business practices and operating conditions of each of the Investor Owned Utilities, there will be significant alterations proposed to some provisions contained in the current settlement terms.
