**Hi everyone. Here are a few pictures of the venue. The room we will be in is that large bank of windows to the left of the front doors.**

**Currently, the plan is that the tables will be mostly in the back of the room, next to the windows, and a few on the sides. They only supply 8 foot standard tables (and naturally chairs). There are electrical outlets in the pillars at the windows and some in the walls. I suggest extension cords should be included in your supply box. There is broadband and wireless accessibility in the room. Please let me know if you have any questions. I would prefer calling our contact myself (or whomever else Lyle or Rachele**

designate) rather than a dozen or so participants flooding her with sometimes the same questions.

Please arrive around 9:00 am to set up, since the broadband forum will be in the same room as the Fair. Loading and unloading is best done at the loading dock accessible from Alameda street at the purple gate. Parking is \$6.50 across First Street (at First and Central streets) and on a first come first serve basis. There are other lots in the area but none as convenient. Light rail transit stop is at Alameda and First street, across from the building and the Dash goes by there too. There are many Japanese restaurants in the area and some others too. The venue is in little Tokyo, about 3 blocks from the civic center itself.
