Please ignore my last email. I think the system must have malfunctioned. I want to circulate a draft resolution early this week for the Desert Sunlight project but need a few pieces of information to complete my analysis. Could you send the following information sometime in the next few days. Thank you.

1) Workpaper tabs BSC Fig 2B and BSC Fig 2C (please see attached workpaper) with comparisons to 2008 solicitation and 2009 bilateral contracts. As stated in the previous email and on p. 7 of the Desert Sunlight Advice Letter, PG&E compared Desert Sunlight with the 2008 RPS Solicitation and with 2009 bilateral contracts. However, the workpaper incorrectly compares the Desert Sunlight bid with 2009 RPS solicitations. Could you correct the data in the graph and make comparisons to 2008 solicitation and 2009 bilateral contracts.

2) Could you also provide a separate graph in Tab Via_Fig that shows the Desert Sunlight contract in comparison to 2008 Bids by Technology as well as 2009 bids. From the Advice Letter, the project was based both on the 2008 shortlist and then evaluated under the 2009 shortlist.
