 Per your request, I have submitted through the CPUC's FTP system copies of the RPS power purchase agreements (PPAs) and amendments listed in the table below. Banking and taxpayer identification information was redacted from the PPAs. Please note that a number of the PPAs attached a form EEI Master agreement without any amendments to the form.
