Hi Don,

We are hopeful that we can agree on common objectives and come to agreement about appropriate metrics. Like the IOUs, we want the PPM process to be successful. However, given the amount of time that has elapsed and the miscommunication that appears to have taken place on the PPM process, we do not believe a supplemental AL is a realistic option. We anticipate that the PPM AL will go to a resolution, because substantial differences remain between what the IOUs submitted and staff's interpretation of what constitutes compliance with PPM-related requirements in D.09-09-047.

The plan is for ED to distribute it's proposed PPMs and rationale for selection in advance of the meetings. The purpose of the meetings is to discuss and (hopefully) come to agreement on a reasonable set of metrics, whether they originated from the IOUs in their filing, from staff in its review of the filing, or in real time at the meeting. It is unlikely that staff will be able to make commitments to any potential changes in the meetings, because we will need time to reflect, analyze and discuss internally. That said, we are very receptive to feedback and remain open-minded about the final set of metrics. To the extent that we are unable to reach agreement on one or more metrics, ED will explain its position in the draft resolution. All parties will have an opportunity to comment on any points of disagreement during the comment period.

I hope this clarifies our intent at these meetings. Thanks!
