September 2nd Commission Meeting

TO: PARTIES TO DRAFT RESOLUTION E-4354

Enclosed is Draft Resolution E-4354 of the Energy Division recommending recipients for the second round of CSI RD&D funds focused on improved solar production technologies and innovative business models. It will be on the agenda at the September 2, 2010 Commission meeting. The Commission may then vote on this Draft Resolution or it may postpone a vote until later.

When the Commission votes on a Draft Resolution, it may adopt all or part of it as written, amend, modify or set it aside and prepare a different Resolution. Only when the Commission acts does the Resolution become binding on the parties.

Comments may be submitted electronically.

Comments shall be limited to five pages in length plus a subject index listing the recommended changes to the Draft Resolution and an appendix setting forth the proposed findings and ordering paragraphs.

Comments shall focus on factual, legal or technical errors in the proposed Draft Resolution. Comments that merely reargue positions taken in the advice letter or protests will be accorded no weight and are not to be submitted.

Reply comments will not be accepted.

Late submitted comments will not be considered.
