- 9/28: US Senate Committee on Commerce, Science, and Transportation's Subcommittee on Surface Transportation and Merchant Marine Infrastructure, Safety, and Security held a legislative hearing titled "Assessing the San Bruno, California Explosion and Other Recent Accidents." Chris Johns testified. The hearing was chaired by Senator Lautenberg (D-NJ) and three other Senators were in attendance, including Senator Boxer (D-CA). The hearing lasted approximately two hours and consisted of three witness panels. The first panel was Senator Feinstein, who detailed the impacts of the San Bruno accident and discussed the legislation she and Senator Boxer introduced regarding pipeline safety. Senator Feinstein took note of the efforts PG&E has made to "step up and take responsibility." The second witness panel included representatives from the NTSB and PHMSA. NTSB provided some information on the timeline of events surrounding the San Bruno accident and answered several questions regarding automatic shut off valves. PHMSA received questions on the adequacy of its oversight of the nation's pipelines system and its staffing levels. The third panel consisted of Chris Johns, a representative from the Pipeline Safety Trust, the Mayor of San Bruno, and Paul Clanon, Executive Director of the CPUC. Most of Senator Boxer's questions to the third panel were directed at Chris Johns and Paul Clanon and related to: the response time of PG&E the night of the accident, the effectiveness and impact of automatic shut off valves, the adequacy of PG&E's response plan, PUC oversight, the status of pipeline segments on our Top 100 list, and spending on our natural gas system. Chris Johns' testimony and his

responses to questions were well received. During the course of the hearing, Senator Boxer requested that PG&E follow up with her office on several items. The Federal Affairs team will work to coordinate follow up with the Senator's office. Federal Government Relations Leads: Steve Kline and Melissa Lavinson

Continues to respond to inquiries from local, state and federal officials as well as community leaders and stakeholders regarding the incident. Coordination with officials for press conferences, tours of the site, shelters and emergency centers.

## **Local Government Relations**

Continued outreach and meetings with local elected officials and public officials regarding inquiries on pipeline safety.

- **9/28:** On Monday, [Redacted], Steve Whelan, and Jessica Hogle attended a meeting with Congresswoman Jackie Speier in her San Mateo district office. In addition to the Congresswoman's staff which included her district director, (Richard Steffen), senior advisor (Brian Perkins), and district press secretary (Katrina Rill), other attendees were: San Bruno Public Works Director Klara Fabry, San Carlos Mayor Randy Royce and Interim City Manager Jeff Maltbie, Tom Brocher, United States Geological Survey, Dr. Kofi Inkabi, UC Berkley Civil and Environmental Engineering, San Bruno Vice Mayor Rico Medina, and San Bruno Assistant City Manager Jim O'Leary. The overall purpose of the meeting was to address her questions from our meeting with her last week, and discuss some general policy questions related to her proposed legislation which she released during a press conference that morning. The overall tone of the meeting was cordial. The meeting topics included automatic/remote controlled shut off valves versus manual shut off valves. The Congresswoman's legislation would require pipeline owners and operators to install proven or effective remote or automatic shut off valves on existing pipelines in high risk and high density areas, high seismic risk areas, and in all new construction or

replaced pipelines. Her legislation would also require pipeline owners and operators to provide state regulators and state and local emergency responders with their emergency response plans and other critical information they need to respond in the event of an emergency. The Congresswoman asked if first responders should be trained to shut off PG&E's manual valves in the event of an emergency. We also discussed the D shaped loop at the site of the accident, on lines 132 and 109. Now that we have capped line 132 of the D shaped loop, she would like to know why we don't just pull it out and no longer operate that line. She indicated that this segment of line 132 is a "political problem and profound liability" for PG&E, and we should remove it and locate it elsewhere. We indicated that we are currently looking into all options for L132. Finally, the Congresswoman would like PG&E to pay for a constituent who lives in a green tagged residence near the reconstruction/clean up area to live somewhere else to address air quality and breathing concerns. The Congresswoman's office will send Jessica Hogle her name and contact information.

- Briefed Assembly leadership and utility committee staff on the gas transmission pipeline system and the top 100 list. Answered all the questions that were asked and also provided a list of where the 47 locations were with respect to Assembly and Senate Districts so they know which district representatives have a location on the map. - Senate Energy, Utilities and Communications Committee along with the Senate Public Safety Committee will be scheduling a joint hearing in the State Capitol on Tuesday, October 19. Due to the fact



that the NTSB has not issued any preliminary findings to this point the focus of the hearing will be on maintenance and inspection programs for natural gas pipeline infrastructure. Contact: Kent Kauss

### **Community Relations**

Assembling a team for the implementation details of the San Bruno Recovery Fund efforts to produce FAQ's, messaging, press releases, etc. Completed materials for communications with impacted homeowners as noted above.

To date, more than **350** checks have been disbursed to affected customers.

Community Relations established a process to deploy ten volunteers each day at the San Bruno recovery center from Monday, September 20 through Thursday, September 30. Volunteers will provide assistance to customers and act as the liaison to the PG&E claims team.

As of 9/27 PG&E employees have personally donated over **\$67,000** (combination of **\$20,350** – direct online donations and **\$46,700**– estimated vacation sale gross donations). The giving site was closed on 9/24. Employees are now redirected to donate via the Campaign for the Community.
