Pacific Gas & Electric Co.'s presentation to the Milpitas City Council last week regarding the installation and operation of SmartMeters on Milpitas homes and businesses was delayed again.

For almost a year, PG&E's rollout of its controversial SmartMeters has included customer complaints alleging spiking utility bills, meter malfunctions and a generally inaccurate reading of electricity usage. PG&E has insisted the new meters more accurately register power usage for its customers than older systems thereby saving customers and the utility money.

Benchmarks for safety and testing for pipeline operators should be considered by regulatory authorities, Pacific Gas and Electric Co. told U.S. lawmakers.

A natural gas pipeline burst Sept. 9, sparking a massive fireball that ripped through a San Bruno, Calif., neighborhood. The explosion killed seven people and destroyed 37 homes. Authorities say they believe internal corrosion may have led to the failure of the pipeline.
