## San Bruno Media Update

Thursday, September 23, 2010

Updated 12:00 p.m.

### Summary

Coverage this morning focused primarily on the cleanup in San Bruno, and confirmation by the coroner's office of the deaths of three relatives who had been presumed dead. The San Francisco Appeal reported that a bill was introduced today by Senator Leland Yee to offer disaster relief to those affected by the incident. Broadcast coverage highlighted area gas leaks including a leak reported in Orinda which featured an interview with PG&E spokesperson, [Redacted]. [Redacted] Late this morning Bay Area media began reporting on today's CPUC meeting and resolution to appoint an independent review panel. A KGO-TV story includes an interview with [Redacted] stating that PG&E will comply fully with costs associated to the incident.

### Developments to Date

- CPUC is meeting today to address costs associated with San Bruno incident and will appoint a "Blue Ribbon" panel to investigate the incident
- Demolition and debris clean up in San Bruno will begin today; concerns have emerged regarding hazardous material associated with the clean up process
- A senate bill was introduced today to help with disaster relief

CPUC Demands Top to Bottom PG&E Review

Dangers lurk amid San Bruno fire ruins
